



In 2014, voters approved \$13.5 million in bond debt to: 10
"[repair] leaking roofs, renovate heating, electricaland meet safety code"
What will this new bond Measure do? 7

Apparently, roofs need replacing every 10 years, along with HVAC systems.
With this newest "temporary" tax, Woodside Elementary School District is going to repeat many of the same repairs as were specified in 2014's project list, but at more than twice the cost. Actually, if you add the interest due to the lenders, it will be more like <u>four times the cost</u> .
Bonds are like mortgages: gigantic loans requiring payments—of both principal and interest.
Vote NO to tell Woodside Elementary School District's trustees that the place for known, // recurring maintenance expenses is their annual budget—not decades-long debt burdens on our children and grandchildren.

• 2017-18: 12.92% of district children failed to meet state standards.
